The primary purpose of the Grande Prairie Regional Hospital Foundation is to work with the community to raise and manage funds, to enhance patient care and further education at the QE II Hospital and the new Grande Prairie Regional Hospital. In total, the Foundation has invested nearly \$14 million for innovative medical equipment, major projects, educational opportunities and programs that enrich the health of patients and their families, none of which would be available otherwise.

The QE II Hospital Foundation was founded in 1984, and in 2015 a re-branding was needed in order to support both the existing QE II Hospital and the new hospital which is on schedule to open in 2019. This re-branding required approval from CRA and the Alberta Health Minister. New logos were designed with an open heart symbolizing CARE which encompasses the care provided to patients in hospital, caring staff and care from our community who support us so greatly. This process was complex but essential to ensuring we continue to support and enhance healthcare in our region.

We are very grateful for the support provided by our community friends, organizations and businesses who help to deliver vital funding to enhance health services for thousands of patients each year. In a city with a population of 68,000 and a community outreach of more than 250,000, medical needs for our patients continue to rise. Technology is always improving and by donating you will positively impact health care services for residents in the entire Peace Country Region both today and for the future.

The Grande Prairie Regional Hospital Foundation is entrusted with the stewardship and management of donor funds with the primary goal of enhancing patient care for our residents in this region. Our organization originated in 1984 when our first legacy gift was made by Sarah Joan Alward, a local Grande Prairie resident. Four years later, the first Festival of Trees was held and in 1995 we introduced the Visual Arts program. In 2004 Butterfly made her début as our Therapeutic Clown at the QE II Hospital and she still brightens the faces of sick children today. We are thankful to have exciting



programs and campaigns all directed at enhancing patient care. We would like to thank the community for all their support over the years and we look forward to continuing to serve in the future.

Key to Care Campaign

On November 14th at our 27th annual Festival of Trees Gala we announced with great excitement our Key to Care Capital Campaign. This \$20 million dollar campaign is the largest campaign we have ever undertaken and in fact is the largest capital campaign of any rural hospital foundation in Alberta. The purpose of this campaign is to raise funds to enhance patient care for the new Grande Prairie Regional Hospital which is currently under construction. This aggressive campaign considers specific healthcare needs of today and encompasses opportunities that will affect positive change in the future. The ability to adapt to new innovations in technology and modern medical advancements is crucial in providing a high-quality healthcare system for our community.

Lyle Carlstrom and Dr. Cled Lewis co-chair this remarkable campaign cabinet. Key Innovations (up to 9 million dollars) - This component of the campaign is the largest segment and will allow us to purchase specialized medical equipment for the new Grande Prairie Regional Hospital and the existing QEII Hospital. This utilized for educational opportunities for patients and staff. lofty goal will provide funding for the purchase of new and exciting technological enhancements that healthcare in our Region has not seen before.

Key Equipment For Life Legacy Fund (6 million dollars) - This fund is being created as an Endowment Fund and will be utilized to purchase specialized medical equipment using the annual financial returns of the fund. This fund allows us to not only purchase specialized medical equipment today; it will allow us to purchase equipment for generations to come. This legacy fund truly commits to the long term needs of our community and will provide consistent financial opportunities for enhancing patient care for this community and region.

The Key to the Art of Healing (3 million dollars) - This component of the campaign enriches healing in ways outside of the medical technologies and supports. With funds raised in this component we plan to beautify the Hospital, and warm the hearts of our patients and their families. The funds will provide the opportunity to purchase art works, sculptures and design. We will also be able to develop beautiful gardens and will even explore the emotional healing of music. The arts have been proven to be highly beneficial to patient recovery and emotional healing.

The Key to Knowledge (2 million dollars) - This component is designed to help to develop opportunities for learning in ways not currently available. Funding will be including the opportunity for distant learning.

Money raised during this event goes towards the Parent Bereavement program at the QEII Hospital which provides bereavement mementos and materials to families who have experienced loss.



Through generous community donations, a SiPAP System was purchased for the QEII Hospital Neonatal Intensive Care Department (NICU). This crucial equipment helps our youngest patients by providing a non-invasive neonatal ventilating solution which protects their fragile lungs. A significant benefit for this state-of-the-art technology is the reduced necessity to intubate infants, increases oxygenation and helps to reduce the number of days on a ventilator. Improving an infant's ability to breath quickly and safely provides better health outcomes during their most critical first days.

To make this news even more exciting, the NICU received a second SiPAP System the same day! This wonderful gift was purchased by Dr. Paramesha Pillay Pediatrician at the QEII Hospital. His caring and dedication to the children within our community is greatly appreciated and we know our babies will have the best care. The Therapeutic Clown program reduces stress for our youngest patients and their families by comforting them during treatments or while having medical procedures. Butterfly is a positive influence in situations which can be confusing, scary or painful to a child. Our Clown creates long lasting relationships and can bring a smile during these trying times.

At the QEII Hospital we consider "Butterfly" part of the hospital healthcare team, joining in the healing and wellness efforts of the patients, and supporting all types of healthcare delivery systems.

She cruises the halls of the QEII Hospital dispensing

her own brand of medicine – healing through laughter and joy. The car she drives is equipped with an IV pole and two spots to carry oxygen tanks so that no child has to be left behind, each child can drive the car and get their very own Clown Car license.

The Therapeutic Clown Program is not funded by public health dollars. Without sponsorships and your donations we would not have this valuable program. Your support will truly make a difference in a child's life and also in the lives of their families.

The New Grande Prairie Regional Hospital

The new 64,000 square meter Grande Prairie Regional Hospital is scheduled for completion in 2019. This innovative project has 200 private inpatient rooms and a wide range of health care services including a new cancer center that will include two state-of-the-art radiation vaults. Other services include, emergency and surgical services, medical, intensive care, obstetric, NICU, outpatient services and of course pediatric services.

Family engagement is instrumental for patient recovery and this new facility will incorporate a new AHS Family Centered Care Model. This is significantly different than what we currently have at the QEII Hospital as each patient will have the opportunity for a family member or close friend to stay with them in their private room. Each room will be equipped with a piece of furniture that can be used as a bed for that family member to stay. This model of care promotes family involvement thereby promoting healing in a calming environment while improving communication for better health outcomes. Exciting additions to this site include a 1100 stall parking parkade and a newly dedicated space within the hospital for GPRC to provide educational services to healthcare related students. This partnership is unlike any other in the Province and being able to provide training onsite will be essential to engaging students to work in this facility in the future. The Grande Prairie Regional Hospital also has the ability to integrate future expansion to this site recognizing the positive growth rate of the City of Grande Prairie and the region.

At opening the Grande Prairie Regional Hospital will serve 250,000 patients each year and is projected to increase to 300,000 patients by 2025. This regional facility is like no other in the Province and will be an incredible health facility for our community.

INDEPENDENT AUDITOR'S REPORT

To the Directors of the Grande Prairie Regional Hospital Foundation

We have audited the accompanying financial statements of Grande Prairie Regional Hospital Foundation, which comprise the statement of financial position as at March 31, 2016 and the statements of changes in fund balances, revenues and expenditures and changes in financial position for the year then ended, and a summary of significant accounting policies and other explanatory information.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian accounting standards for not-for-profit organizations, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Independent 'Auditor's Responsibility

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Basis for Qualified Opinion

In common with many charitable organizations, the Foundation derives revenue from various cash sales, donations and contributed materials, the completeness of which is not susceptible of satisfactory audit verification. Accordingly, our verification of these revenues was limited to the amounts recorded in the records of the Foundation and we were not able to determine whether any adjustments might be necessary to contributions, excess of revenues over expenditures, current assets and net assets.

Qualified Opinion

In our opinion, except for the possible effects of the matter described in the Basis for Qualified Opinion paragraph, the financial statements present fairly, in all material respects, the financial position of Grande Prairie Regional Hospital Foundation as at March 31, 2016 and the results of its revenues and expenditures and its changes in fund balances and cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations.
